



GENERAL CONDITIONS

1. This Agreement is between the Customer and W.C. ESHENAUER & SON, INC., here and after referred to as "the Company" or "Company".
2. This Agreement is only available as an additional service for the customers that purchase all of their heating oil from the Company. This Agreement will automatically terminate if the customer ceases to purchase the Company's heating oil; fails to pay for all heating oil, parts, labor, or other chargeable items when due; or renders or permits anyone other than the Company to service the burner or equipment, unless so instructed beforehand by the Company.
3. There shall be no obligation upon the Company to perform any service or provide parts after termination of this Agreement; upon termination, there is no refund or credit allowed.
4. This Agreement is offered to all customers and is subject to an inspection and approval of their equipment before the Agreement becomes valid. If upon inspection, customer's equipment is found to be unacceptable or obsolete, customer's Agreement coverage will be canceled and a prorated refund will be returned to customer. Repairs required to upgrade equipment to an acceptable condition are excluded and will be charged separately at prevailing rates.
5. This Agreement will become effective immediately following the inspection and approval of the customer's equipment, as required above, and payment of the Service Agreement invoice. This Agreement is effective for a twelve (12) month period and will renew automatically each year.
6. **ONLY EMERGENCY SERVICE will be performed outside normal working hours.** EMERGENCY SERVICE shall be defined as: NO heat, NO hot water, or any other condition the duty serviceman feels could create an unsafe condition or cause damage to property. Nonemergency work, if requested, will be billed at our standard overtime rates.
7. **No service calls** caused by improper setting of thermostat, switches in "off" position, empty fuel tanks, filling boilers with water, draining expansion tank, replacing fuses, or tampering with equipment are covered by this Agreement.
8. This Agreement does not cover repair or service of equipment damaged due to fire, flood, lightning, freeze-ups, any acts of God, or civil disturbance.
9. The Company's obligation to furnish parts specifically listed herein shall be subject to their availability through usual supply sources. Replacement of obsolete items for which parts are not available will be performed on a time and material basis.
10. The Company warrants that all services performed and parts installed by it shall be performed in a workmanship-like manner and warranted for their intended use only.
11. The Company shall be liable solely for repairs to the covered equipment. Under no circumstances shall the Company be liable for any consequential or resultant damages from defective equipment; loss or damage resulting from operation or non-operation of said equipment; delays in performing service; making repairs or installation of parts; or because of strikes, accidents, explosions, shortages, or other conditions beyond the control of the Company.
12. This Agreement contains the entire Agreement of the parties hereto and there are no promises, terms, conditions, or obligations other than printed herein.
13. The Company does not insure against fuel storage leakage or any damages to persons or property resulting from tank leakage. This policy does not cover any cleanup, removal, remediation, or other costs of compliance with any laws, rules, or regulations regarding fuel storage tanks.
14. The Company will pay up to \$1,000 toward the replacement of your tank, once tested and qualified by an ultrasonic oil tank inspection, if a tank leak occurs subsequent to this test due to internal corrosion or due to a manufacturer's defect, or if a non-leaking tank is identified for proactive replacement. While we cannot guarantee that a leak will not occur or your tank will not fail after testing, we are providing these new services with the hope that by testing and monitoring, we are offering a long-term proactive tank replacement program for our customers. Accidental damage is not covered by ultrasonic oil tank inspection program. The program does not cover environmental cleanup, property damage, waste disposal services, or other damages or losses caused by a tank leak or system failure, even if the tank has been tested and qualified ultrasonically and is enrolled in the ultrasonic oil tank inspection program.
15. Customer will receive an annual 10% discount on the lower-priced option of any bundled Service Plans upon renewal of the combined Plans.
